RICHLAND COUNTY COMMUNITY PARTNERS RESPOND TO PUBLIC HEALTH EMERGENCY

Richland Center, WI: A virtual Emergency Operations Center meeting was held again this morning to share information between Richland County officials and community

partners in a joint response to the COVID-19 pandemic.

Public Health Manager/Local Health Officer, Rose Kohout announced that as of 2:00pm

Tuesday, April 21st the Wisconsin Department of Health Services (DHS) confirmed that

in the state of Wisconsin there were 4,620 confirmed cases of COVID-19, 47,841 have

tested negative, there were 242 deaths, and 1,252 hospitalizations due to COVID-19. Of

those that tested positive for COVID-19 in the state of Wisconsin, 27% have been

hospitalized. There are now 9 confirmed cases of COVID-19 in Richland County, 194

have tested negative, and there has been 1 death as a result of COVID-19 at this time.

continues to offer COVID-19 testing out of their "Respiratory Illness Evaluation" drive-

thru service 7 days a week from 8am-5pm. COVID-19 testing is now being offered to
