RICHLAND COUNTY COMMUNITY PARTNERS RESPOND TO PUBLIC HEALTH EMERGENCY

Richland Center, WI: A virtual Emergency Operations Center meeting was held again this morning to share information between Richland County officials and community partners in a joint response to the COVID-19 pandemic.

Richland County Emergency Management Director, Darin Gudgeon announced that as of 2:00pm Thursday, April 23rd the Wisconsin Department of Health Services (DHS) confirmed that in the state of Wisconsin there were 5,052 confirmed cases of COVID-19, 51,456 have tested negative, there were 257 deaths, and 1,318 hospitalizations due to COVID-19. Of those that tested positive for COVID-19 in the state of Wisconsin, 26% have been hospitalized. There are 10 confirmed cases of COVID-19 in Richland County, 212 have tested negative, and there has been 1 death as a result of COVID-19 at this time.

The Richland Hospital Incident Command Team has started the planning process to begin phasing in a re-opening of their facility for voluntary medical procedures. Patients needing hands-on medical care should always call the main number (608) 647-6321 BEFORE coming to the hospital. The Richland Hospital Coronavirus Hotline remains available 24 hours/day and patients should call (608) 604-9953 BEFORE coming to the hospital. COVID-19 testing is still being offered out of the Richland Hospital "Respiratory Illness Evaluation" drive-thru service 7 days a week to anyone displaying symptoms.

The "Whole Community Recovery" Steering Committee has been meeting regularly to identify the economic impact of COVID-19 on Richland County families and determine a suitable long-term recovery structure for our citizens. This committee will bring together key individuals in sectors such as finance, education, business, industry, and mental health in an effort to bring assistance to all that have been impacted. The local needs and available resources for each of the sectors will be studied to link those affected with an appropriate level of case management.

Richland County Community Partners shared the status of their individual organization's emergency response, reviewed staffing and PPE (Personal Protective Equipment) needs and local inventory, continued efforts to assist small business owners, and discussed priority topics to support the community through the recovery process.
