RICHLAND COUNTY COMMUNITY PARTNERS RESPOND TO PUBLIC HEALTH EMERGENCY

Richland Center, WI: A virtual Emergency Operations Center meeting was held again

this morning to share information between Richland County officials and community

partners in a joint response to the COVID-19 pandemic.

Public Health Manager/Local Health Officer, Rose Kohout announced that as of 2:00pm

Thursday, April 30th the Wisconsin Department of Health Services (DHS) confirmed that

in the state of Wisconsin there were 6,854 confirmed cases of COVID-19, 69,394 have

tested negative, there were 316 deaths, and 1,512 hospitalizations due to COVID-19. Of

those that tested positive for COVID-19 in the state of Wisconsin, 22% have been

hospitalized. There are 12 confirmed cases of COVID-19 in Richland County, 255 have

tested negative, and there have been 2 deaths as a result of COVID-19 at this time.

The Richland Hospital Coronavirus Hotline remains available 24 hours a day 7 days a

week and patients are still being instructed to call (608) 604-9953 BEFORE coming to

the hospital. The Richland Hospital continues to offer their "Respiratory Illness"

Evaluation" drive-thru service from 8am-Noon 7 days a week and COVID-19 testing is

being offered to anyone displaying symptoms. Richland Hospital Emergency Management Coordinator, Lyle Kratochwill announced that the hospital plans to offer non-emergent surgical procedures starting Monday, May 4th and preparations continue for reopening their facilities sometime in May.

Richland County Economic Development Director, Jasen Glasbrenner reported that the Wisconsin Manufactures and Commerce (WMC) released a "Back to Business" Plan that is designed to strategically open Wisconsin businesses based on a number of risk factors and offers employers a clear vision for when and how they can begin to operate. The plan utilizes an algorithm to determine the risk for an individual business based upon a number of factors. The business would then be issued a risk level; the higher the risk, the more precautions they would be required to take to avoid further spread of COVID-19.
