RICHLAND COUNTY LOCAL FOOD RESOURCES AVAILABLE FOR THOSE IN NEED

Richland Center, WI: Richland County Emergency Management Director, Darin

Gudgeon reports that Richland County community partners assembled a "Whole

Community Recovery Steering Committee" to identify the economic impact of COVID-

19 on Richland County families and link those affected with resources. Below you will

find the local food resources available in the month of May for those in need:

 <u>Southwestern Wisconsin Community Action Program</u>: SWCAP is hosting a "Pop-up Food Pantry" in the following areas (schedule changes weekly): MUSCODA-Friday, May 1st from 2:00-3:00pm in the Muscoda Village Parking Lot. BOAZ-Monday, May 4th from 10am-11am in the Community Building Parking Lot. READSTOWN-Monday, May 4th from 12pm-1pm in Tourist Park. VIOLA-Monday, May 4th from 1:30pm-2:30pm in Banker Park. LONE ROCK-Wednesday, May 6th from 12:30pm-2pm next to the Fire Station.

SWCAP representatives will need to collect your first and last name, city of residence and household size.

• <u>Richland Community Food Pantry</u>: Open **Wednesday**, **May 6th** from 4-5:30pm and every Wednesday through the pandemic. The weekly food distributions at the Lighthouse Chapel, 345 S. Cairns Ave, Richland Center parking lot will continue as a drive-through. Clients should stay in their cars while an intake person secures their full name, Richland County address, and number of members in the family. All clients should present a piece of mail that contains their name and address. A volunteer will then place the food in their vehicle. Due to heavy demand, there is a "one visit per month per family" rule.

- <u>Lone Rock Food Pantry</u>: Open **Thursday, May 14th** from 5-6pm at 222 W. Pearl Street, Lone Rock. Food will be distributed to people while they remain in their vehicles.
- <u>Viola Food Pantry</u>: Open **Saturday**, **May 16**th from 9:00-11:00am at 225 N. Washington Street, Viola. Food will be distributed to people while they remain in their vehicles.
- <u>Community Food Pantry of Spring Green</u>: By appointment only **Monday, May 18th**. Call (608) 459-5512 or email <u>communityfoodpantry@yahoo.com</u> to schedule your appointment time. Normal distribution times are 10:30am-12:30pm and 4:30-6pm. Food distribution can only be done by a scheduled appointment in advance; otherwise you will have to wait or come back. Serving the River Valley School District Community.
- <u>Second Harvest Food Pantry</u>: Open Thursday, May 21st at 3:30pm until all food is distributed and then the 3rd Thursday of each month. The monthly food distributions will be at Richland Center Fellowship, 26700 Fellowship Lane, Richland Center as a drive-through service.

FoodShare assistance may also be an option. You can apply by using the ACCESS website: <u>www.access.wisconsin.gov</u> or by calling 1-888-794-5556 Monday-Wednesday and Friday, 8am-4pm and Thursday 9am-4pm.

All local school districts continue to offer meal delivery to any child 18 years of age or younger living within their district boundaries. This program is NOT INCOME BASED. It is intended to allow families the ability to receive free breakfast and lunch for any child living in their household. Please contact your school district for more information.
