RICHLAND COUNTY COMMUNITY PARTNERS RESPOND TO PUBLIC HEALTH EMERGENCY

Richland Center, WI: A virtual Emergency Operations Center meeting was held this morning to share information between Richland County officials and community partners in a joint response to the COVID-19 pandemic.

Public Health Manager/Local Health Officer, Rose Kohout announced that as of 2:00pm Wednesday, June 17th the Wisconsin Department of Health Services (DHS) confirmed that in the state of Wisconsin there were 23,454 confirmed cases of COVID-19, 423,736 have tested negative, there were 712 deaths, and 3,128 hospitalizations due to COVID-19. Of those that tested positive for COVID-19 in the state of Wisconsin, 13% have been hospitalized. There are now 15 confirmed cases of COVID-19 in Richland County, 1,266 have tested negative, there have been 4 deaths, and 10 individuals who had tested positive have been released from quarantine.

The Richland Hospital Coronavirus Hotline and drive-thru respiratory care services remain **CLOSED**. Patients needing hands-on medical care should call the hospital main number (608) 647-6321 or clinic main number (608) 647-6161 before coming to the

facility. The Richland Hospital campus continues to phase in a re-opening of their facility for voluntary medical procedures and Primary Care visits will continue to expand over the next few weeks.
