RICHLAND COUNTY COMMUNITY PARTNERS RESPOND TO PUBLIC HEALTH EMERGENCY

Richland Center, WI: A virtual Emergency Operations Center meeting was held this morning to share information between Richland County officials and community partners in a joint response to the COVID-19 pandemic.

Public Health Manager/Local Health Officer, Rose Kohout announced that as of 2:00pm Wednesday, September 2nd the Wisconsin Department of Health Services (DHS) confirmed that in the state of Wisconsin there were 77,129 confirmed cases of COVID-19, 1,191,548 have tested negative, there were 1,142 deaths, and 5,961 hospitalizations due to COVID-19. Of those that tested positive for COVID-19 in the state of Wisconsin, 7% have been hospitalized. There are now 55 confirmed cases of COVID-19 in Richland County, 3,550 have tested negative, there are 13 active cases, and 38 individuals who had tested positive have been released from quarantine. Of those 55 individuals who tested positive, 50 individuals have been recovering at home, 5 have been hospitalized, and
